Dear Parents and Carers,

I write to you with further information regarding the **NEU (National Education Union) Strike Action on Wednesday 5th and Friday 7th July**, and thank you for your patience regarding this matter. At present and following previous days of strike action, the indications are that the number of staff choosing to take industrial action will mean it is not possible to run lessons as normal. For this reason, our school, like many schools across Norfolk and England, **will partially open**.

The school will remain open for the following groups only:

- **Dove**
- **Nursery**
- **Reception**
- **Year 1**
- **Year 6**
- **Year 10**

We ask that children in all other year groups work at home on these days. Please note, these days do not count as an absence for children who are asked to stay at home.

In addition, where possible we are seeking to make adjustments to any planned activities and trips that were scheduled for these days to ensure children do not miss out on these important experiences. Information relating to these will have been/be communicated to you directly by the respective phase.

For families where children attend our Nursery setting, please note that the Nursery will be **OPEN**.

There will inevitably be some disruption to learning for those in school, but we will endeavour to keep this to a minimum. Lessons in school will run for the Dove Hub, Reception, Y1, Y6, and Y10, but we are likely to make changes to the curriculum for that day for some classes.

This partial closure is very different from that which we experienced during lockdown(s) and as a result our remote offer and in-school provision will differ. Work will be provided via Oak National Academy and BBC Bitesize - this will be communicated in a separate message. Children who do not have internet access will be issued with a physical pack that they can work through. Please contact the school office if you would like a pack stating your child's name and class/Year Group **by midday on Monday 3rd July** .

We have limited places for children of critical workers (*those who are frontline NHS or emergency services only*) or who are deemed vulnerable*. Please complete the google form ([click here](#)) if you would like to request a place within this provision which will be confirmed via email on Tuesday 4th July. **Please note, to support our planning, forms must be completed by midday on Monday 3rd July.**

If your child is in receipt of Free School Meals and you would like a packed lunch for your child (*this does not include Universal Infant Free School Meals*), please inform the school office by midday on Monday 3rd July by completing this form ([click here](#)).

In the Primary Phase, children who have requested a packed lunch for Wednesday 5th will be given this at the end of the school day on Tuesday. This will be the same on Thursday if lunch has been requested for Friday 7th.


In the Secondary Phase, children who have requested a packed lunch for Wednesday 5th July should collect this from the canteen at 3:20pm on Tuesday 4th. A packed lunch for Secondary Phase students for Friday 7th July will be available for collection from the canteen at 3:20pm on Thursday 6th.

I want to reiterate that this strike is happening because of a national dispute between the unions and the government over teachers' pay and not because of any issues or disputes with our school.

Negotiations are ongoing at a national level between the Trade Unions and Government Ministers. The information in this letter is therefore subject to change should any agreements be reached over the coming days and we will continue to communicate with you as soon as such information becomes available.

I recognise the disruption that this may cause to you and your family and appreciate that many of you will be faced with some significant juggling over the coming days.
